#### What and Who?

- Parks & Gardens UK is managed by the charity Parks and Gardens Data Services (PGDS).
- The development of this web resource was made possible by a grant from the Heritage Lottery Fund and over 22,000 volunteer hours of contributions in-kind, mainly from the County Gardens Trusts.
- The searchable database now contains 7,158 site records, 2,116 person records, 299 organisation records, 1,778 references, 76 archives and 4,282 digital Images.
- On average, there are 18,000 unique visitors each month originating from 172 countries.



- War and Gardens will focus on the untold story of gardens and gardening during and after the First World War
- its impact on the social and physical landscape of gardening and the wider lessons to be learned today
- With our network of partner charities engaged in the conservation, research and learning activities for gardens (including the Association of Gardens Trusts, The Garden History Society and Parks & Gardens UK), we will research a major exhibition for the summer of 2014.

- It will present research on how soldiers in the trenches complemented their diet with vegetable (and grew flowers)
- how the country as a whole was encouraged to grow its food
- the little explored designs of gardens around war memorials
- gardening in PoW and Internment camps
- the effects of war on landscapes in cities and on country estates.
